

Joseph Sanzari

Joseph M. Sanzari was born in Hackensack, New Jersey on February 28, 1946. He was raised in Carlstadt and began working and learning about the construction industry at the age of 12. He has continued to work in this field, specializing in the construction of highways, roads and bridges.

He is the President of JOSEPH M. SANZARI, INC. a company which specializes in highway construction.

He performs major construction work on the New Jersey Turnpike and for the New Jersey Department of Transportation highways, roads and bridges. Joe is in a Joint Venture with J. Fletcher Creamer & Sons known as Creamer-Sanzari. Creamer-Sanzari was responsible for the reconstruction of the Route 4 and 17 overpasses, the largest highway project in the State of New Jersey. Under Joe's leadership, this project was completed eighteen months ahead of schedule. His recent accomplishment with Creamer-Sanzari was the rebuilding of the Essex Street Bridge in Hackensack. Creamer-Sanzari was recognized by Engineering News as one of the top 25 contractors in the country.

Joseph Sanzari is a proud member of numerous civic and cultural organizations, sharing his unique brand of energy and talents on both a local and state level. Current positions include Chairman of the Board for the HackensackUMC Pascack Valley Joint Venture and member of Hackensack Meridian Health Network Board of Trustees. He is a former

Chairman of the Board of Governors for the Hackensack University Medical Center and Hackensack University Health Network Board of Trustees. He is also a Vice Chairman on the board of the Foundation for Free Enterprises, a former Chairman of the Bergen County Economic Development Corporation and former commissioner of the Palisades Interstate Parkway.

Joe is devoted to his family which consists of his son Joseph, Jr. and daughters, Theresa, JoAnn and Tina and their spouses and six grandsons; twins Jared Michael and Nicholas Joseph, Michael Joseph, Joseph Martin, Timothy Edmund, Luke Edmund and a granddaughter, Mia Charlotte.





Chief Phyllis Bindi

East Orange PD

Chief Phyllis Bindi made history at the East Orange Police Department in January of 2017 when she obtained the rank of Chief of Police; the first female to ever be promoted to this position in the City of East Orange. She also made history in September 2016, when she was the first female ever promoted to the rank of Deputy Chief in the City of East Orange Police Department. The Chief has been leading a Department of nearly 200 sworn personnel for 2 years now, in a densely urban City that borders the largest City in the state.

Chief Bindi was first sworn in as an Officer in 1991 and during her 26+ year career in law enforcement has served in multiple units while rising through the ranks to now lead a Department that is recognized as the leader in technology-led, real time policing. Chief Bindi was promoted to the rank of Sergeant in 2002 and assigned to the Enhanced Community Safety Team, which was responsible for suppressing all street-level crime, with an emphasis on narcotics and gang-related crimes. Shortly after her successful stretch as supervisor of the Safety Team, Chief Bindi was then promoted to Lieutenant in April of 2006 when she was assigned as the Commander of the Safety Team, before becoming responsible for the Field Training Unit, which monitored and mentored all new officers. As commander of the Field Training Unit, Chief Bindi was instrumental in shaping the mindset of the new officers, teaching them the objectives and goals of the department, officer safety, and how to be the best officer. In 2012, she was promoted to Captain and was designated as the Tour Commander of the evening patrol division. Chief Bindi, as the

commander, reduced crime for four consecutive years on the busiest of all patrol tours; which is also historically plagued with violent crime. Due to her success on the evening tour and the crime reduction she achieved, Chief Bindi became the first Special Operations Coordinator, responsible for all of Operations including but not limited to patrol, investigative, and intelligence units.

Over her impressive and successful law enforcement career, Chief Bindi has been the recipient of multiple awards and recognitions for bravery and operational excellence from various local and state associations. She has been an integral part in the East Orange Police Department's change in culture by facilitating a proactive as opposed to reactive police department, decreasing crime by over 75% over the past 15 years, and making the City a safer place to live and conduct business in. Her success throughout her career, dedication to the community and its' members, and to the personnel within the police department, is what Chief Bindi prides herself on, and allows her to remain a role model for the nearly 25% female contingency within the Department.

Some of Chief Bindi's accolades include the Traiblazer Award presented to her by the National Organization of Black Women in Law Enforcement, Inc. (NOBWLE), the Glenn D. Cunningham Law Enforcement Award presented by the Hoboken Branch NAACP for her outstanding leadership in the field of Law Enforcement.

Lifetime Achievement in Law Enforcement Award

Undersheriff Jessica Plumeri

Mercer County Sheriff's Office

Born in Trenton and raised in both Trenton and Hamilton Township, New Jersey, Jessica Plumeri graduated from Hamilton High North (Nottingham) in 1990 and attended Mount Saint Mary's University in Emmitsburg, Maryland. Jessica graduated in 1994 with a Bachelor of Arts degree in Sociology with a concentration in Criminal Justice.

After college, she was hired as a Detective with the Mercer County Prosecutor's Office. After graduating from the New Jersey Division of Criminal Justice Academy, Jessica was assigned to the Grand Jury, Trial and Megan's Law Units. As her career progressed, she was assigned to the Prosecutor's Special Investigations Unit where she began her passion for investigations involving the illegal distribution of narcotics.

While learning on the job with the Prosecutor's Office, Jessica continued to advance her knowledge and skills by completing the Drug Enforcement Administration (DEA) Basic Narcotics School, "Top Gun" Narcotics School and the REID Basic Interrogation Course. Jessica continued to advance her knowledge by attending many additional seminars and classes with the FBI, DEA and various state and local law enforcement agencies. Jessica also completed the New Jersey Division of Criminal Justice Physical Training Course and is certified by the Police Training Commission as a certified New Jersey Physical Training instructor. Jessica utilized this training as an instructor at the Mercer County and New Jersey Division of Criminal Justice Police Academies.

In 1999, Jessica entered the graduate program in education at The College of New Jersey (TCNJ). She attended classes at night and in 2001, she graduated with her Masters of Arts Degree in Teaching.

Shortly after earning her Master's degree, Jessica decided it was time for a change

and new challenges. In 2002, Jessica was hired by the Hopewell Township School District as a second grade teacher. She loved being a teacher and working with children. It did not take the community long to appreciate her love of teaching. In 2010, Jessica received the Teacher of Year Award from the Hopewell Township Board of Education.

While teaching was a rewarding and fulfilling experience, there was still something missing. After much thought, Jessica realized her true passion in life was law enforcement, and she returned to the Mercer County Prosecutor's Office. As a returning law enforcement officer, Jessica had to complete training at the New Jersey Division of Criminal Justice Academy. Once again, her passion for law enforcement was evident and upon completion of her training in 2011, she received the Police Training Commission Distinguished Recruit Award.

Upon returning to the Mercer County Prosecutor's Office, she was assigned to the Trial Unit, assisted in homicide investigations and returned to the unit that was her true passion, Special Investigations, whereby she served as a member of the Mercer County Narcotics Task Force. As a detective in the Special Investigations Unit, Jessica participated in over 3000 narcotics investigations, 300 of which were undercover investigations. These investigations involved the distribution of narcotics and guns with the Mercer County Narcotics Task Force, the DEA, FBI, United States Marshal's Service, the New Jersey State Police and various state and local agencies in New Jersey, Pennsylvania and New York. Jessica again completed advanced training and became a certified undercover officer through a prestigious program hosted by the New Jersey State Police and FBI. In addition to being an instructor and the Mercer County Police Academy and the Division of Criminal Justice Academy, she also instructed at the Undercover Narcotic Investigative Training School (U.N.I.T.) hosted by the New Jersey Office of the Attorney General.

During her law enforcement career, Jessica has received numerous awards from the Mercer County Prosecutor's Office, the Drug Enforcement Administration and local and state law enforcement agencies. This includes, in 2001, when she received the West Windsor Police Department Certificate of Excellence for an undercover operation that benefited the entire community. Jessica has also assisted the DEA as an undercover officer resulting in the seizure of large amounts of narcotics.

In 2016, Mercer County Sheriff John A. Kemler appointed her Undersheriff. As Undersheriff of the Mercer County Sheriff's Office, Jessica is responsible for the Mercer County Sheriff's Office Trenton-Mercer Airport Division, Policy Development and Training, Court Security, and numerous other essential duties related to warrant services and the capture of fugitives.

Jessica is an avid runner and has completed the New York City marathon on three occasions and will participate in the Police Unity Tour in 2018. She resides in Lawrence Township with her daughter Nina and her son Sam.
